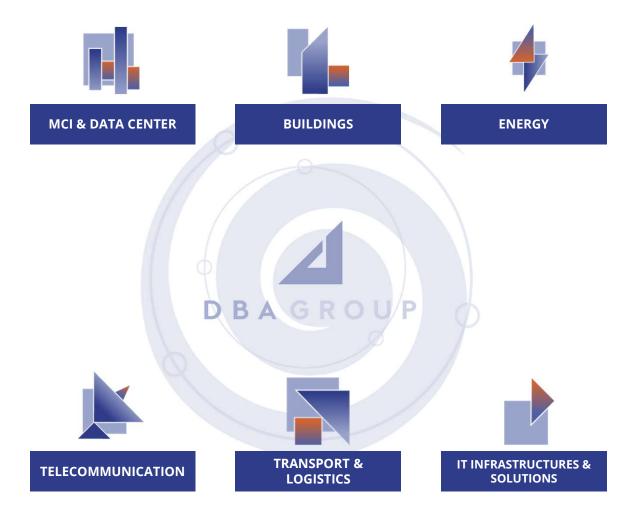

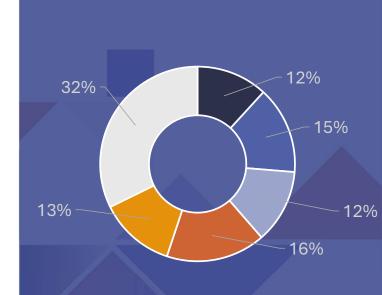

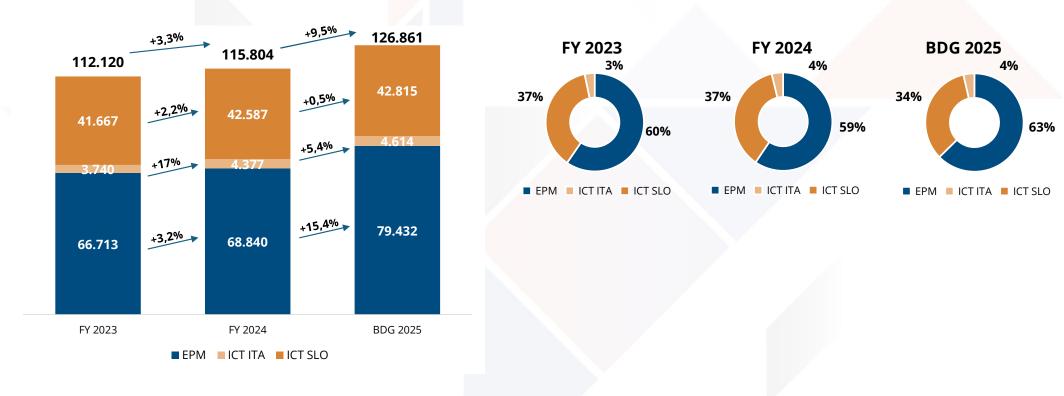

## **KPI FY 2023 vs FY 2024 vs BDG 2025 - Revenues (000/€)**

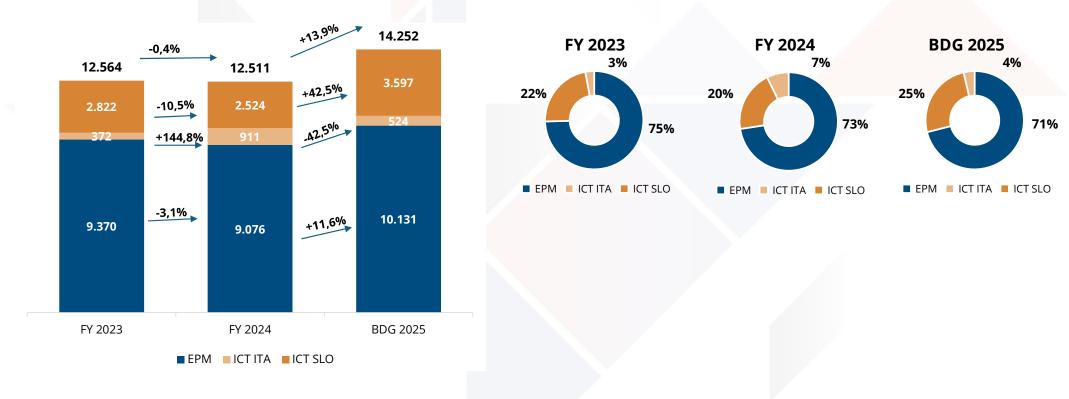


#### Revenues FY 2024:

At the end of 2024, the Revenues reaches €115,8 million, +3,3% compared to 2023. This result is driven by the EPM Business Unit, which increases year-over-year by +3,2% (+€2,1 million) compared to FY 2023. In FY 2024, the ICT ITA Business Unit improves by +17,0% (+€637k), while the ICT SLO Business Unit stands at €42,5 million, up +2,2% (+€920k). The 2025 budget values include higher revenues resulting from the new group perimeter, which from 2025 includes Serteco, IFG, and Com Com.



## KPI FY 2023 vs FY 2024 vs BDG 2025 - EBITDA ADJ (000/€)

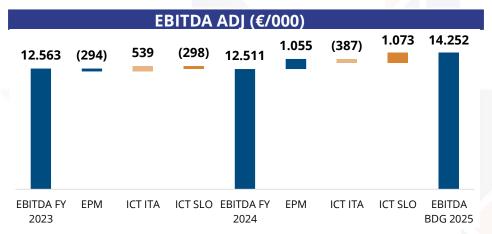


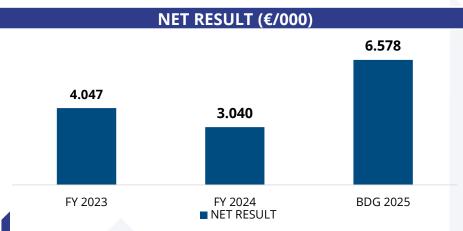
#### **EBITDA ADJ FY 2024:**

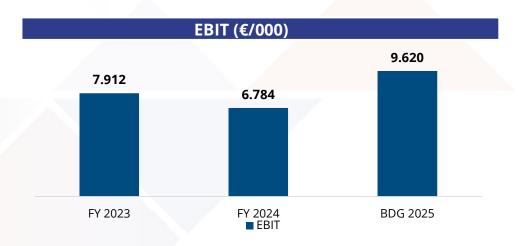
At the end of 2024 the Group's EBITDA adjusted remains in line with the previous year, standing at  $\leq$ 12,5 million (EBITDA margin 10,8%). The EPM Business Unit contributes to the EBITDA adjusted with  $\leq$ 9,1 million (- $\leq$ 294k), while the ICT ITA Business Unit and the ICT SLO Business Unit contribute with  $\leq$ 2,5 million (- $\leq$ 298k) and  $\leq$ 911k (+ $\leq$ 539k), respectively.

#### **EBIT - NET RESULT FY 2024:**

The reduction in EBIT, and consequently in the Net Result, for FY 2024 is due to approximately €500k in higher depreciation related to previous years' M&A operations (General Planning and SJS eng, 25% share) and approximately €500k for an increase in the impairment of receivables (LC partner DC Caserta).

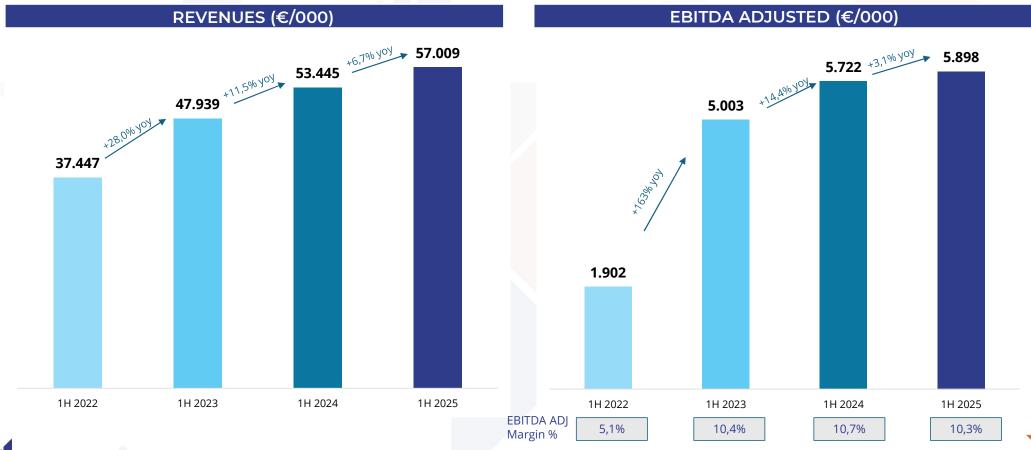

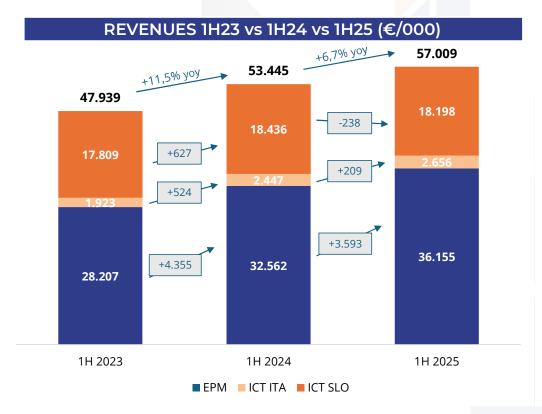

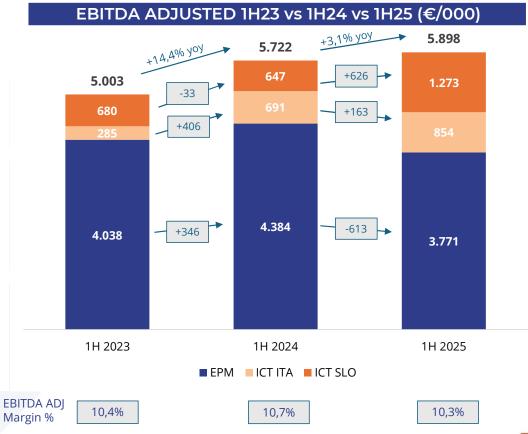


## **GROUP KEY FINANCIAL 1H2025**



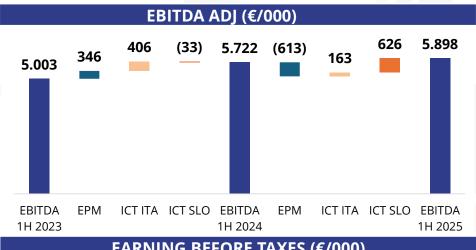

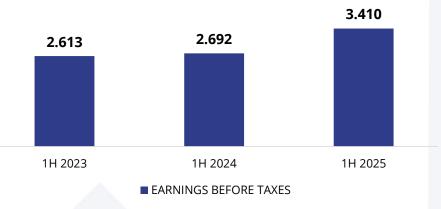


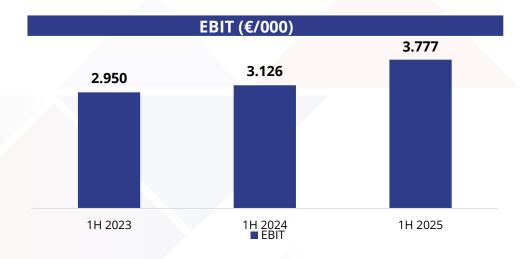


## **OPERATING PROFITABILITY 1H2025**



### EARNING BEFORE TAXES (€/000)

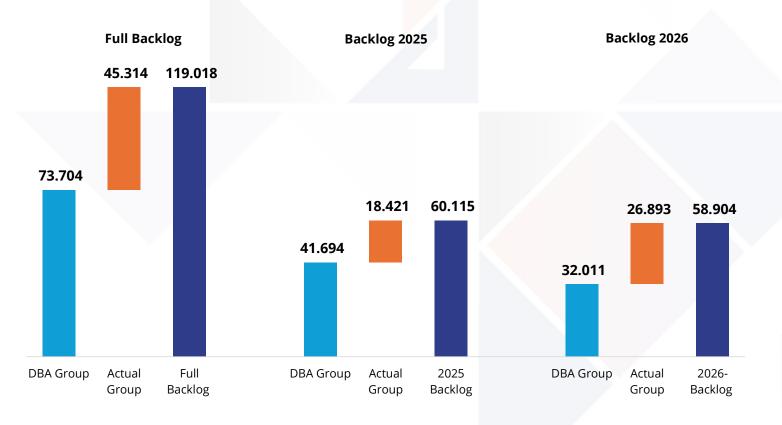




#### **OPERATING PROFITABILITY 1H 2025:**

Adjusted EBITDA grew up by 3,1% compared to 1H 2024, despite no adjustments being recorded in 2025. The result was driven by solid growth in ICT Slovenia ( $+ \le 0,6m$ ) and ICT Italy ( $+ \le 0,2m$ ). EBIT in the first half of 2025 increased by  $\le 0,6m$ , and profit before taxes also improved by  $\le 0,7m$ .

## **BACKLOG AS OF JUNE 2025 (€/000)**

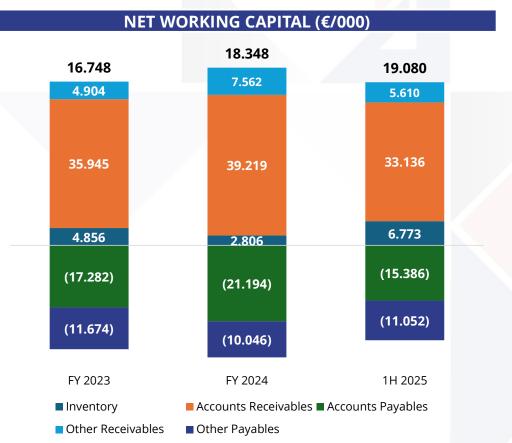


#### **Backlog June 2025**

As of June 2025, DBA Group's total backlog amounted to €73,7m, while Actual Group's backlog stood at €45,3m, for a total backlog of €119,0m. For the second half of 2025, DBA Group reports a backlog of €41,7m, while Actual registers €18,4m. DBA Group already has a backlog of €32,0m scheduled for subsequent years (2026 onwards), whereas Actual Group's backlog beyond 2026 amounts to €26,9m.



### **EVOLUTION OF NET WORKING CAPITAL**

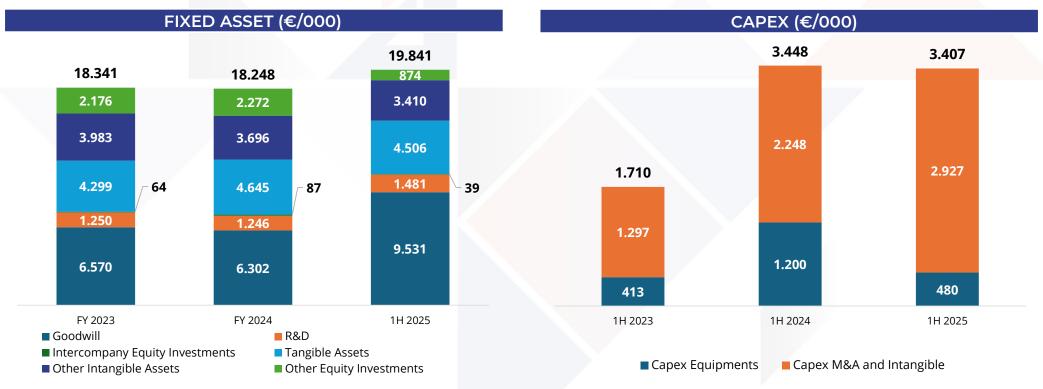


#### NWC 1H 2025:

In the first half of 2025, Net Working Capital increased by approximately €0,7 million, remaining substantially aligned with the year-end 2024 figures. Both trade receivables and trade payables decreased, resulting in a balanced impact on the net position. Specifically, trade receivables fell from €39,2 million to €33,1 million, while trade payables decreased from €21,2 million to €15,4 million. This trend primarily reflects the cyclicity of the business, coupled with the company's ability to effectively manage its obligations in line with its operational requirements. The rise in inventories is mainly attributable to the majority of projects expected to be completed by the end of the year.



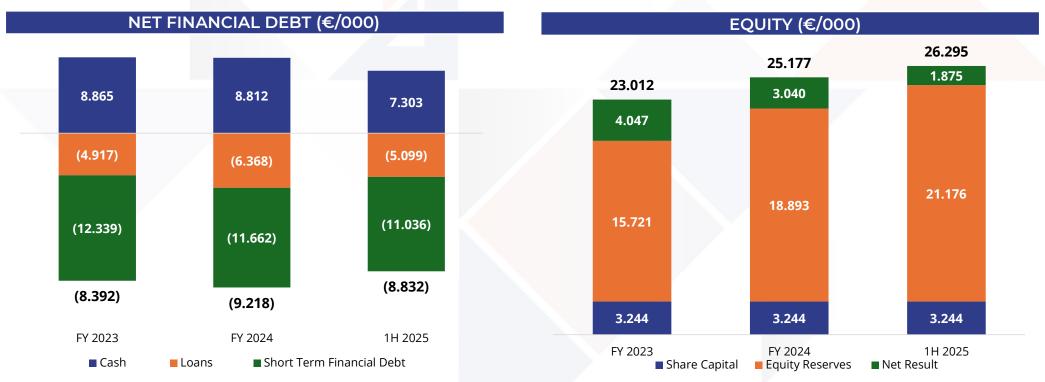
### FIXED ASSET AND CAPEX



#### **FIXED ASSETS E CAPEX 1H 2025:**

Compared to FY 2024 and FY 2023, Goodwill increased due to the acquisitions of Serteco, IFG, and COM COM. Other Equity Investments decreased in 1H 2025 due to liquidity disposal, amounting to €0,9m. The other items composing the Fixed Assets remained substantially in line with FY 2024 and FY 2023, both in terms of their weight and as characteristic of a service-oriented company.

## **NET FINANCIAL DEBT AND EQUITY**



#### **NET FINANCIAL DEBT E EQUITY 1H 2025:**

Between FY 2024 and 1H 2025, the Net Financial Position improved from -€9,2m to -€8,8m, mainly due to a decrease in short and long-term debt of €1,9m. This was possible even with the net debt created for the acquisition of IFG, Serteco, and COM COM. As for Equity, it reached €26,3m in 1H 2025, up €1,1m compared to the FY 2024 balance. The amount of Equity increased mainly due to the net results of the period, offset by the dividends paid.
